1. Determination of quorum (5 active members present)

• 11 active members present \rightarrow quorum reached

2. Proposal amend the Pathoplexus Statutes to allow appointment of a Treasurer.

- Opening bank accounts in all banks we approached required two individuals with signing authorities present in person.
- Proposal: institute the office of a Treasurer. The specific changes to the statues are discussed, including the definition of the role of treasurer.
- Additions to the statues
 - Addition of the office of the treasurer
 - Definition of the role of the treasurer
 - Update of the "Signing authority" to reflect that one Executive Board member along with the Treasurer.
- The assembly votes on the amendment of the statutes with **unanimous support for the amendment**.

3. Proposal to appoint a Pathoplexus member based in Basel as the Treasurer. This requires an Absolute Majority (as defined in the Statutes).

- Proposal: Chaoran Chen puts himself forward as a candidate for the role of the treasurer
 - Chaoran Chen has basic knowledge of accounting practices and has handled the previous interaction with the tax office.
- No other candidates
- The assembly votes unanimously to elect Chaoran Chen as the treasurer of Pathoplexus.
